



## Newfoundland Club Of Florida Rescue Rescue Placement Agreement

(Please read carefully. This is intended to be a legally binding document)

The undersigned adopter(s) agrees to abide by the terms of adoption, as listed:

1. You agree to pay an adoption fee of \$375 to the Newfoundland Club of Florida.
2. You agree to become a member of NEWFFLA and remain a member as long as you own the dog.
3. Your home shall provide a safe environment, which complies with local ordinances, and provides adequate shelter from the cold and hot weather. The dog will be kept as a house dog, not a kennel ,yard or outside dog. Furthermore, the dog will not be kept chained or on a tie out, at any time. The primary function of this dog is to be a pet and companion and shall never be allowed to roam at large, without supervision. This dog should also always carry proper ID tags.
4. You agree to provide proper care for the dog, including but not limited to veterinarian care, proper food, health care and care related to general well-being, i.e., love, affection.
5. If for any reason, the adoption is not satisfactory to the adopting party or if the adopter(s) fails to comply with all the terms/conditions of this agreement, or if any misrepresentations have been made by the adopter(s) during the entire life of the adopted dog, the dog must be returned to NEWFFLA immediately. The dog may not be transferred to any other person, firm, or corporation, for any reason, whatsoever. NEWFFLA will accept return of said dog at any time, for any reason.
6. NEWFFLA must be notified upon the death of said rescue dog. You agree to notify NEWFFLA if dog is lost for more than 24 hours.
7. NEWFFLA reserves the right to periodically check on the dog to ensure that you are in compliance with this agreement. NEWFFLA retains the right to reclaim the dog, when warranted, due to neglect, abuse, inadequate care or breach of contract. You agree to relinquish custody of the dog to a member of NEWFFLA immediately upon request, without legal writ or order, until the situation warranting the reclamation is rectified.
8. Should it become necessary for NEWFFLA to take part in any legal action whatsoever in reference to the adopted dog, including but not limited to enforcing the provisions of this agreement, the undersigned adopter(s) agree to pay all court costs, legal fees, and attorney's fees, their own and those of NEWFFLA and NEWFFLA authorized agents.
9. NEWFFLA and its representatives accept no responsibility for damage or injury caused by this dog, or guarantee as to its present or future medical condition or temperament.

Other terms (check all that apply)

- The club will assume monetary responsibility to have the dog spayed or neutered. The dog must be spayed after the dog has experienced one (1) heat cycle or neutered between 18 and 24 months. Documentation must be sent to NEWFFLA within two (2) weeks of procedure.
- A refresher obedience course is urged to establish a more rapid respect and rapport between you and your dog.
